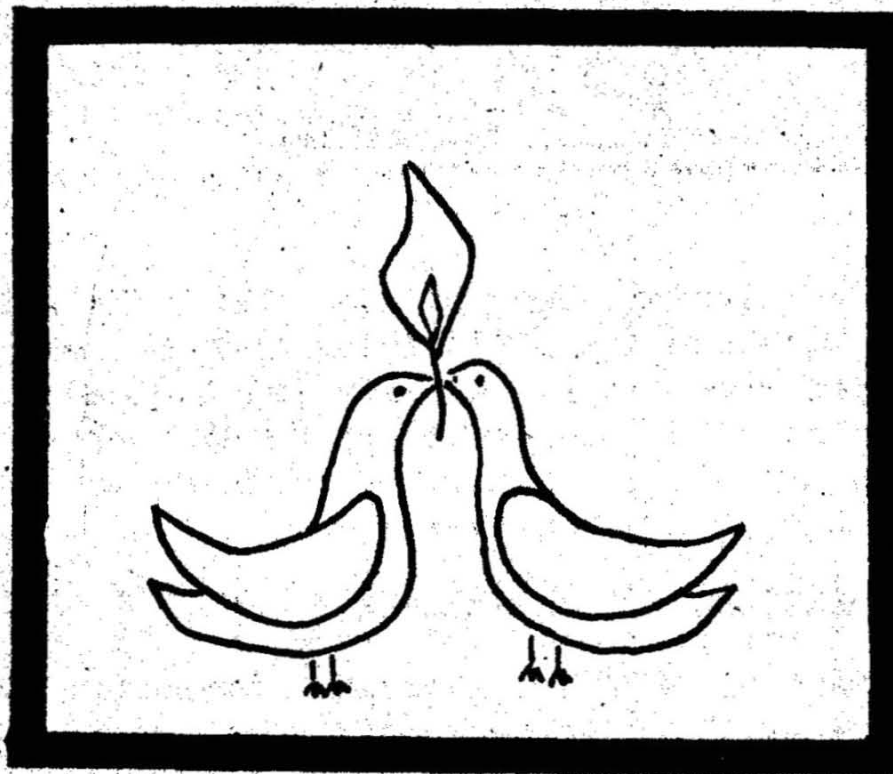

A continuing theme of our Common Flame is our desire to encourage gift giving that serves those in need, instead of those already privileged (like us.)

So as the season to be spending approaches, we would again ask our family and friends to consider the following alternatives:

United Campus Ministries serves not only students, but also the poor, the oppressed, and the outsiders of the Athens, Ohio, university community. UCM religiously supports peace and anti-hunger groups, seeks to include homosexuals in the church, and provides professional religious counseling to students and the community. Tax deductible contributions may be sent to UCM, 18 N. College, Athens, OH 45701

Housing and Economic Appalachian Development (HEAD, Corp.) is the business promotion branch of the Commission on Religion in Appalachia. HEAD provides technical assistance and capital to locally owned housing and production ventures throughout Appalachia. Contributions, again tax deductible, may be sent to HEAD, Corp., Box 504, Berea, KY 40403.



Center for Constitutional Rights is a legal resource for minority rights, union organizers, and women's groups. CCR is currently representing twenty-six (26) members of Congress who are suing President Reagan to require the withdrawal of U.S. soldiers unlawfully stationed in El Salvador. ## A Caribbean Honeymoon.

We saw farming and fishing coops, free milk distributions, and a universal literacy campaign. The headquarters for the ruling New Jewel Movement (aligned with Europe's socialist parties), we found, was in a back room of the Methodist Church.

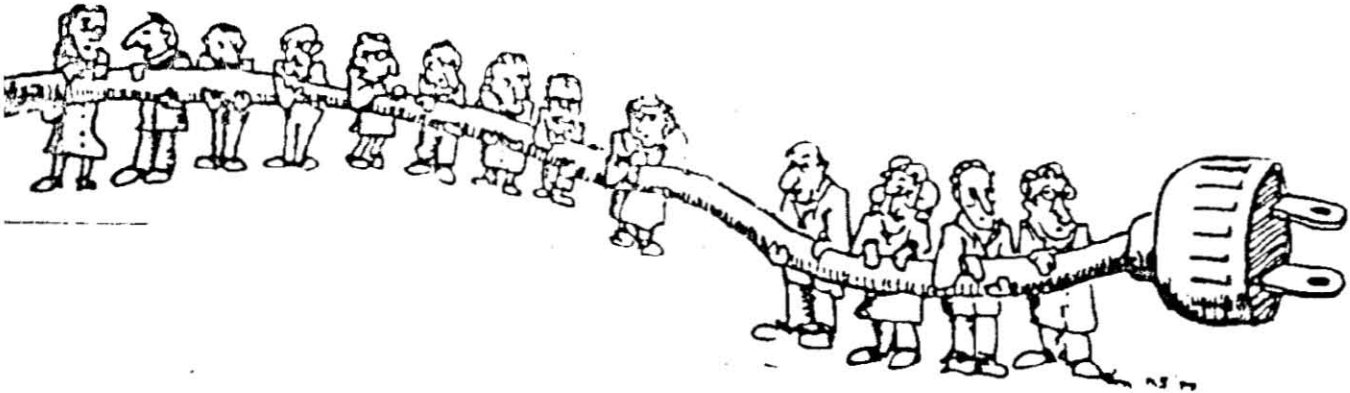

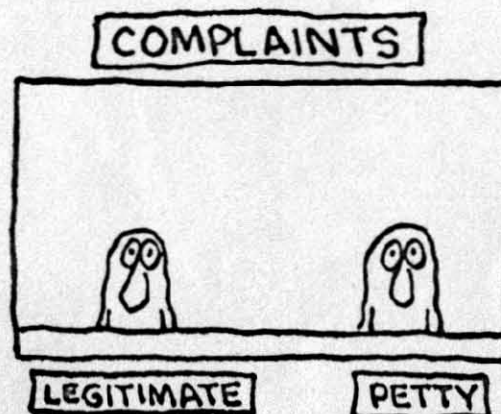
